

Planning reform

- 1. We acknowledge the Operation Sandon special report, Vic housing statement, and reforms already gazetted
- 2. Affirms the ambition of LG to address housing supply and affordability crisis'
- 3. Asserts reforms must be based on complete understanding of the causes of the crisis
- 4. Recognises that any fundamental reforms to the planning system require genuine consultation and engagement between State and Local Government
- 5. Confirms LG stands ready to increase housing supply
- 6. Endorses MAV's Local Government's Vision for Planning in Victoria
- 7. Engages with councils
- 8. Expresses concern with disconnect between gazetted reforms and Operation Sandon special report
- 9. Commits to good faith engagement with the State Government to work in genuine partnership on further planning reforms
- 10. Formally requests that the Planning Minister enter into a Memorandum of Understanding with the MAV that establishes this partnership and enables genuine input and improvement from the Local Government sector to any and all fundamental planning system reforms



Exempt rural councils from the Windfall Gains Tax

Protect, enhance and expand open spaces

- 1. Recognise open space is critical to healthy and active communities
- 2. Mandate higher minimum public open space requirements for stateapproved planning proposals
- 3. Reform joint-use agreements to improve access to public school grounds
- 4. Work more closely with LG to identify opportunities and need for public space

Retain and protect community voice in system

- 1. Recognise the subject matter expertise in LG and partner with it to improve the system
- 2. Retain community voice as key pillar of system
- 3. Resource councils to effectively carry out our central role in system



Change VPP in relation to use of car stackers

1. Make urgent changes to the Victoria Planning Provisions and prepare a new Planning Practice Note to provide clear policy direction aimed at improving the design, useability, specifications and accessibility of car stackers

Golf course land planning guidelines

1. Review the Planning Guidelines for the Conversion of Golf Course Land for other Purposes, and their practical application.

Surplus state-owned land

1. Consider rezoning state land and sale of unused state land to provide revenue, allow private industry to develop housing, commercial or industrial use, and improve presentation of highly visible land



Address barriers for regional workers accommodation

1. Consider permit exemptions for Rural Worker accommodation in the Green Wedge Zones and release of other reforms from the Planning for Melbourne's Green Wedge and Agricultural Land Review.

1. Make resources available for small rural councils to enable to remain compliant with the FOI Act 1982





On Australia's First Peoples issues, councils call for ...

Maggolee partnership and advocacy for LG's involvement in Treaty implementation

- 1. Assist in the promotion of Maggolee and resources
- 2. Help produce model policies and best practice guidelines on LG changes relating to issues affecting Aboriginal and Torres Strait Islander people with statewide relevance, consistent with the Treaty negotiation framework, Selfdetermination, and State Government policy and legislation
- 3. Establish a relationship with the First Peoples Assembly of Victoria and keep the membership informed of the progress of Treaty negotiations and in particular where Treaty outcomes may involve LG in their implementation
- 4. Involve Local Government as early as possible in designing a Treaty implementation program




