Entry Requirements

Students seeking admission to the Master or Graduate Diploma of Health (Child and Family Health Nursing) must:

- Hold current registration with the Australian Health Practitioner Regulation Agency (AHPRA) as both a Registered Nurse and a Midwife, with no conditions on their registration.
- Meet recency of practice requirements as per the Nursing and Midwifery Board of Australia, which includes:
 - A minimum of 12 months full-time experience in both Nursing and Midwifery,
 - OR
 - A minimum of 5 years full-time experience in either Nursing or Midwifery.
- Have a confirmed clinical placement in a Maternal and Child Health Service.



Course Structure

The Graduate Diploma of Health (Child and Family Health Nursing) comprises 120 Credit Points made up of two 30 Credit Point units and four 15 Credit Point units. The structure of the full-time course is outlined in the table below.

Students may undertake the program part-time over **18 months or 2 years**.

Mid-year entry is available for part-time students, starting with non-clinical units in the first semester. Clinical placement must be secured and will commence the following year

Clinical Practicum

The Graduate Diploma of Health (Child and Family Health Nursing) requires students to complete 300 hours of clinical experience, including:

- 240 hours in Local Council Maternal and Child Health (MCH) services
- 60 hours in specialty services closely associated with the MCH Nurse role

The table below outlines the units within the program that include clinical practicum and the required hours.



Applicants may begin the admission process to Federation University while awaiting the outcome of their Expression of Interest (EOI). Once placement is secured, upload a letter of confirmation to Federation University Admissions to progress your application to enrolment.

Confirmation of placement with a Local Council MCH service is mandatory for consideration for entry into the Master's or Graduate Diploma of Health (Child and Family Health Nursing).

Information on applying for a clinical placement is available on the Municipal Association of Victoria (MAV) website. We recommend submitting EOIs early:

- February–March for the Mid-Year Intake
- July–August for the following year's Semester One Intake

Credit

Where a student can demonstrate that they have undertaken an equivalent unit within the last 10 years at a post-graduate level, either at Federation University or another Higher Education provider, an application can be made for Credit.

Course Delivery

The program is delivered in an online learning format, with recommended face-to-face study days delivered at each of our campuses (Berwick, Ballarat and Gippsland). Federation University has a strong track record in delivering successful online education, using a variety of strategies to engage and support learners throughout their studies.

The program adopts a flipped classroom model, where students complete academic activities in advance and then participate in interactive online sessions. These sessions foster dialogue with peers and provide guidance from academic experts.



Case study-based learning is a key feature, immersing students in the role of the Maternal and Child Health (MCH) nurse and reinforcing practical application of knowledge.

Recommended face-to-face study days offer opportunities to connect with peers and develop essential clinical skills. Each clinical unit includes one study day per semester, dedicated to hands-on practice and skill development.

Course Fee Structure

Students undertaking the Master/Graduate Diploma of Health (Child and Family Health Nursing) at Federation University are eligible to receive a Commonwealth Supported Place (CSP).

Additional Requirements

Students will not be permitted to undertake an MCH clinical experience without completing the following mandatory requirements:



- InPlace documentation
- Certification of immunisation status
- Current Working with Children Check
- Current Police Check

NB: It is the student's responsibility to arrange all required documentation. Any costs associated with these checks are the responsibility of the student.
