# RMIT Graduate Diploma in Child & Family Health Nursing

2026 Frequently Asked Questions – GD159 Program

### Do I have to be both a registered nurse and midwife to undertake this program?

Yes, you must hold current registration with the Australian Health Practitioner Regulation Agency (AHPRA) **as both a Nurse and a Midwife in Australia.** 

### Do I have to have practised as both a nurse and a midwife before commencing MCH studies? Yes, the clinical experience requirements are usually

met by:

- **1-Year** full time equivalent) post-registration clinical experience as a registered nurse and
- **1 Year** (full-time equivalent) post-registration clinical experience as a registered midwife (2 Years total)
- Please refer to the program page for other approved combinations of experience

You also need to demonstrate recent clinical experience (1 year EFT in the past 5 years) as a registered nurse or registered midwife.

**Other Electives include:** Indigenous Health, Complex Parent-Infant Mental Health, Health Inquiry Critique (Research) Context of Mental Health Nursing, Therapeutic Initiatives in Mental Health or other courses approved by the Program Manager. Professional electives such as Immunisation and Lactation qualifications may also be considered for approval.

Full time study requires 8 months (Feb to Oct (2026).

Part time students usually complete 2 courses per semester over 20 months (Feb 2026 to Oct 2027).







### Can I apply for credit or RPL for previous postgraduate studies?

Yes. There are 8 courses each worth 12 credit points. Students may apply for credit for equivalent courses they have already completed at a postgraduate level within the past 5 years (specialty courses) or 10 years (non-specialty courses).

Applications for credit are individually assessed by the Program Manager and Course Coordinators. Notification of the outcome of this assessment is sent by the Central University Administrative Office in writing. External courses that may possibly be recognised for credit in 2025 include: Research studies, Mental Health, approved Breastfeeding and Immunisation courses and Infant Mental Health. Students are encouraged to discuss these and other potential credits with the Program Manager prior to enrolment.

#### When can I apply for Credit? How is this done?

You may apply for credit once you have enrolled in the program. Please forward a copy of your certified transcript and course description/study guide and the appropriate completed RMIT application form. It is recommended that enrolled students apply for credit early so that the CSP places allocated to the university can best be utilised.

#### When can I apply for RPL? How is this done?

You may also apply for recognition of prior learning (RPL) once you have enrolled in the program. Please forward a copy of your certified transcript and course description/study guide or other education completed and the appropriate completed RMIT application form. Your application should also include documentation of how you have met the Course Learning Outcomes of the course for which you are applying for RPL, and relevant professional practice. This must be linked to an existing RMIT course at Graduate Diploma level or higher. It is recommended that enrolled students apply for RPL early so that the CSP places allocated to the university can best be utilised. There is an additional form required for RPL applications. Contact the Program Manager for

information about an application for RPL and this additional form. To be eligible to receive an RMIT University award (ie Grad Dip), at least 50 per cent must be completed at RMIT University.

### How much Clinical Placement is required? How is this organised?

This MCH program requires a minimum of 300 hours of clinical experience. Students are assessed against the Victorian MCH Nurse Competency Standards (VAMCHN, 2010/2024). Approx **250 hours** are undertaken in a Council MCH service. Applicants are required to arrange a clinical place with a local MCH service and submit confirmation of this as part of the application process. Student Information Packs are available at the <u>Municipal Association of Victoria website</u> under 'Aspiring MCH Nurses'. There is also a list of Councils and available places.

Approximately **50 hours** is completed as community visits or placement in a range of community child health settings. These include: Childcare, Early Parenting Centres and MCH Line. Most of these are organised by RMITUniversity, and some are arranged by RMIT in collaboration with students. Clinical visits are subject to availability.

**Commonwealth Supported Places (CSPs)** are available on a competitive basis according to government funding. Generally at RMIT most students receive a CSP place. A CSP is a type of university enrolment where the total cost of your study is split into two parts. The Government pays one part - this is a subsidy, and you pay the other part - this is called your student contribution. In 2025, the CSP fee for full time students will be approximately \$4,627. The cost for a standard part-time study over two years is similar. A Commonwealth Government initiative HECS-HELP is also available to help CSP students pay their fees. ### How is this program delivered?

The program is offered over 8 months full time (FT) or over 18 months or 2 years part time (PT).

You will experience a range of learning approaches including learner-centred curriculum, learning activities and projects. **Most content (approx 80%) will be delivered online.** 

Core skills-based content (approx 20%) will be delivered via predetermined face-to-face workshops. Key dates will be provided in advance so that students can have certainty and can plan employment and family commitments.

Learning is promoted by multipl strategies including lectures, tutorials, workshops, online packages, group work, class demonstrations, laboratory sessions, simulation sessions and self-directed learning.

### How do I apply for the Graduate Diploma of Child & Family Health Nursing program?

Full fee-paying places are also available. In 2024 the total

cost for a standard full-time year of study for the full 8 course

program was as approximately \$26,000 (Part time study is the

same cost, spread over 2 years.). The 2026 full fee cost can be confirmed by contacting RMIT Connect as above. Fees

are paid on a semester by semester basis as you progress



Since this is a postgraduate program, applications are submitted directly online on the RMIT website from early August each year. Applicants need to register before creating an online application. <u>Click here for Direct Application</u>.

Once you are registered you can log in at any time to check the progress of your application. You can begin your application and add documents at any time, as available. **Your application will be assessed once it is completed.** 

Successful applicants are encouraged to discuss their enrolment with the Program Manager prior to enrolling to optimise the sequence of studies as some courses have prerequisites.



### What's next...



### When do applications close?

Applications open on 1 August 2025 for the February 2026 intake. Timely applications for the February 2026 intake are expected to close in **early November 2025**. You have a better chance of being offered a Clinical and CSP place (subject to availability) if you apply early. Late applicants may be considered if you meet all requirements and places are still available.

### When will I know if my application has been successful?

Successful applicants will be notified promptly. Please enrol as soon as possible so you can submit a credit application and receive information about submitting clinical preferences, and details for early starting courses. Orientation will be arranged for early December 2025 in readiness for the early start courses.

### When do classes start?

Semester 1 and 2 courses run from February to October 2026

- NURS1023 Child & Family Health Assessment and other early start courses commence mid February onwards.
- All other courses begin the week of 3 March 2026.

There is a 6 week break between semester 1 and 2, (but 2 weeks are reserved for clinical if needed). There are also mid-semester breaks of one week in each of Semester 1 and Semester 2.

### Are scholarships available?

Yes. Scholarships have been provided in the past.

The Victorian state government has previously offered scholarships and bursaries for MCH studies. The MCH program is now located in the Department of Health and it is anticipated they will offer some scholarships to registered nurses and midwives to study MCH nursing in 2026. (These were valued at approximately \$4,250 in 2024). Scholarship details will be available later in August 2025 for the 2026 student intake. Details about the Dept Health scholarships managed by RMIT University can be found here.

A few councils offer annual scholarships to registered nurses and midwives going on to study MCH nursing, generally if a geographical area is short staffed. Preference may be given to applicants living in the local area, but not necessarily. For more information about scholarships, check the Council list where placements are listed on the MAV site or contact your local council MCH Coordinator. Scholarships are often advertised on councils' employment pages. These scholarships range from \$2,000 to around \$4,000.





# How are the Community Placements/Visits organised?

Placements for community visits will be facilitated by the university for groups of students (approx 5 days, mostly intermittent days in semester one).

You will generally be able to nominate a preferred placement from a range of dates, but this does depend on the availability of placements. Community placements include visits / observations at Childcare, Early Parenting Centres, Breastfeeding Support, Sleep and Settling Support, the Enhanced MCH service and MCH Line. You may be required to travel to some placements.

#### Note for Regional and Rural Applicants:

The required Melbourne clinical placements are the MCH Line (3 hours) and a residential Early Parenting Centre (3 days). This is because these services are not readily available outside of Melbourne..

RMIT aims to have students co-located at designated community agencies to optimise placement contracts and OH&S assessments. You may sometimes be required to **travel to a specific community agency.** 

### How is the MCH Service Placement organised?

You will need to arrange placement for your MCH clinical experience with a MCH Service (approximately total 30 days or 6 weeks).

Applicants are encouraged to consider where they would like to complete their specific MCH experience. For most applicants this will be a local municipality. It is important that applicants understand that Councils provide clinical experience to students as a service to the profession, and to facilitate and support the development of new MCH nurse graduates. Councils receive no payment for this role. Obtaining a clinical place is a privilege. Municipalities have different capacities to accept students for placement, for a variety of reasons, including the number of MCH Nurses available to act as preceptors and other projects underway in the municipality or MCH service.

Visit the Municipal Association of Victoria website and download the MCH Applicant Information Pack available there for those interested in MCH studies. This gives step by step details of applying for a clinical place There is also a list of Councils offering placement. This is updated periodically. You can inquire at other Councils not listed if you wish.

- To download the Pack, visit Maternal and Child Health Resources | MAV website . Scroll down to find the link for Aspiring MCH Students. This will take you to a series of links to documents. Click on the link to MCH Applicant Information Pack and EOI updated to download the Expression of Interest (EOI) form for MCH applicants. Some individual Council scholarships are also listed here.
- Complete this form and forward it with your Curriculum vitae to the MCH Manager of the Municipality you would like to approach about possible clinical placement. Type into the Word version of the EOI form.
- Include a statement (paragraph) about why you want to study MCH nursing.
- Submit your application via email or mail.
- Send a copy of the EOI form to Leanne Sheeran Program Manager, RMIT University.

#### Process for Expressing Interest (EOI) in a MCH Clinical Place.

Under the current process for Clinical Placements, some MCH Coordinators will assess Expressions of Interest and CV applications as they are received, and others will hold Expressions of Interest in MCH clinical places and review them collectively at two key times – Mid Sept and late October. Some municipalities will review the Expressions of Interest and CV only and some may conduct face to face or phone interviews, according to their preference. Each Council will have an individual style according to local preferences or needs.

### When will I hear if I have a clinical place? & What if I am unsuccessful?

Applicants will be advised if they have been successful in their expression of interest for a clinical place by the Council. Check with the individual Council when this will be. Applicants who are not successful can apply to further Councils to express interest in a Clinical Place. Applicants are requested to only apply for a **maximum of 3 Councils** at a time with an Expressions of Interest. It is essential once you have accepted a provisional clinical place that you immediately notify any other Councils you have applied to that you have a place and request to be removed from their list of applicants. This frees up places for applicants still seeking a clinicall place and is a courtesy to Councils and MCH Coordinators that you may end up working for once you graduate.



### How is the Clinical placement structured?

When you obtain a clinical place the amount of clinical time you will require in MCH practice will be: approximately 30 days clinical experience between April to September, which equates to 6 weeks of MCH placement. This is completed in the current year of study for full time students. Part time RMIT students complete most of their clinical in the 2<sup>nd</sup> or final year of their studies. However, part time year 1 students complete six (6) days of observational MCH/ clinical workshops in year one including Sleep and Settling support, Breastfeeding support and universal MCH, with the remaining days of clinical placement undertaken in Year 2.

Some Councils will require you to do blocks of placement, others will be satisfied with at least two or more days per weeks. Students are advised to complete 2-4 days of placement per week to optimise learning. All students are required to complete a consolidating five (5) day block at the end of their placement.

Always be very professional and respectful when you approach Councils or other clinical agencies.

## What do I do once I have a MCH Clinical place?

When you have been advised in writing that a Council will offer you a provisional clinical place, you need to accept it in writing within 5 days. Once you have accepted your provisional clinical offer, upload a copy of the clinical offer to your online RMIT application. Please also email a copy to the Program Manager, Dr Leanne Sheeran at <u>leanne.sheeran@rmit.edu.au</u>. Your application cannot proceed without a confirmed MCH clinical place as clinical is a core component required to complete the program.

> Beginning MCH studies requires both a university offer and enrolment AND a confirmation of a provisional clinical place to undertake MCH clinical experience.

In addition to the above MCH Clinical Experience students complete additional days of Community Visits and Placement (approximately 50 hours).

The community visits begin in March, and MCH clinical experience begins from April.

Students are required to complete some prerequisite activities such as introduction to MCH Nursing, physical assessment, child development and child observation in childcare prior to beginning MCH clinical placement.
