Emergency Services and Volunteers Fund (ESVF)

Together, councils have called for:

- Oppose Councils being the collector on behalf of the State Government
- State Revenue Office to collect the Principal Place of Residence (PPR) component of the ESVF, instead of councils
- Fully reimburse costs incurred by the local government sector for the collection, reporting and debt recovery services that it will provide
- Improve transparency and communication
- Ensure that the levy is equitably structured and does not disproportionately burden rural communities or primary producers

Local/State partnership to deliver well planned and connected communities

Together, councils have called for:

- A commitment from the Minister for Planning and the Department of Transport and Planning (DTP) to partner with the MAV and local government
- Undertake deliberative and collaborative engagement in designing and implementing planning system reforms and housing strategies
- Transparent sharing of housing capacity target data and releasing the Standing Advisory Committee Reports for the 10 pilot activity centres so that the lessons and findings can be shared state-wide

- Ensure any additional duties and responsibilities placed on local government are accompanied by the resources needed to fulfil them

FULL RESOLUTIONS:

Emergency Services and Volunteers Fund

The MAV expresses the local government sector's disappointment with State Government's approach to levy collection and implementation of the Emergency Services and Volunteers Fund (ESVF) and opposes Local Government being a collector on behalf of State Government, and calls on the Victorian Government that if Local Government is to administer the funding then:

- 1.Adequate administration funding for local Government to manage the cost of administering the ESVF
- 2. Victorian Government to undertake the community engagement directly with communities
- 3. Transferring Levy Collection to the State
- A) Transfer the responsibility of collecting the Principal Place of Residence (PPR) component to the State Revenue Office, ensuring streamlined and efficient collection while leveraging existing state resources.
- 4. Ensuring an Equitable Funding Model
- A) Continue efforts to reduce the levy burden on all Victorian residents, ensuring the model remains equitable for all communities, especially rural areas and primary producers, reflecting the adjustments made to the Primary Production Land (PPL) rate. 5. **Ensuring an Equitable Funding Model**
- A) Continue efforts to reduce the levy burden on all Victorian residents, ensuring the model remains equitable for all communities, especially rural areas and primary producers, reflecting the adjustments made to the Primary Production Land (PPL) rate 6. Improve Transparency and Communication:
- A) Implement a comprehensive communication strategy to clarify the levy's purpose, allocation, and impact on ratepayers.
- B) Provide a publicly available statement detailing the reasons for changes to the fire services levy, including justifications for any fee increases from 1 July 2025.
- 7 Conduct an Ongoing Economic Impact Assessment:
- A) Undertake periodic economic impact assessments to evaluate how levy changes, including adjustments to the PPR and the primary producer rebate, affect residents, businesses, and the broader community.
- B) Release findings publicly to ensure ongoing transparency and facilitate informed decision-making for future policy revisions.
- 8. Ensure Equitable Fund Distribution:
- A) Deliver a needs-based equalization approach for the distribution of ESVF funds, ensuring that rural and regional emergency services, which are disproportionately impacted by natural disasters, receive adequate and timely funding

FULL RESOLUTIONS CONTINUED

A local and state government partnership to deliver well planned and connected communities

That the MAV, in recognising the ongoing housing affordability crisis and the Victorian Government's commitment in the Plan for Victoria to align the state's settlement strategies with a target of 70% of new homes being built inside established areas, seeks a commitment from the Minister for Planning and the Department of Transport and Planning (DTP) to partner with the MAV and local government to:

- 1.Undertake deliberative and collaborative engagement in designing and implementing planning system reforms and housing strategies. Specifically:
- A) support the role of Local Government as the primary decision maker for planning applications
- B) undertake meaningful community engagement, while maintaining broad third-party appeal rights in strategic and statutory planning decisions

C) ensure the transparent sharing of housing capacity target data.

- D) recognise that meaningful engagement with local government will strengthen the next 50 activity centre plans, noting that engagement on the 10 pilot centre was ineffective
- E) require all future activity centre planning processes to release supporting reports F) require that activity centre planning is subject to transparent and rigorous review that enables cross examination of witnesses by councils
- G) support and encourage local government's critical role in delivering context-sensitive planning outcomes across ESD, integration of housing with infrastructure needs and sustainable transport options, and delivery of affordable housing through partnerships H) engage with industry and private sector stakeholders to address barriers to construction, such as economic viability and workforce capacity

I) Acknowledge the unique growth patterns and infrastructure constraints of rural and peri-regional areas and ensure planning strategies are appropriately tailored

J) Engage with local government, the community housing sector & communities to implement mandatory affordable housing provisions into the Victorian planning system. Minimum mandatory affordable housing provisions must be implemented through relevant legislative & other regulatory changes, informed by research into an appropriate statewide rate higher mandatory percentages for affordable housing must be provided in urban renewal areas.

Coastal inundation and erosion

That the MAV calls on the Victorian Government to address the impacts of coastal inundation and erosion by:

- 1. Articulating, simplifying and streamlining the environmental and infrastructure management roles and responsibilities of the various agencies operating around Port Phillip Bay and the Victorian coastline;
- 2. Establishing an ongoing fund for emergency works required to address the impacts of coastal inundation and erosion, including beach repairs and sand renourishment; and
- 3. Fully funding flood prevention and adaptation measures around Port Phillip Bay and the Victorian coastline.

FULL RESOLUTIONS CONTINUED

Addressing Homelessness

That the MAV calls on the Victorian Government to address homelessness across the state by:

- 1. Increasing the level of funding for the specialist homelessness service workforce, including assertive outreach services based in the social support sector.
- 2. Fund a coordination function based in Councils to lead prevention activities and guide service coordination efforts across community support, community safety and public amenity services.

Ensuring financial sustainability of councils

- 1. That the MAV call upon the Victorian and Commonwealth governments to work with Victorian local government to ensure councils are sustainably resourced to continue providing critical services and infrastructure to local communities, including through:
- 2. Responding to the issues raised in MAV submissions to State and Commonwealth parliamentary inquiries into financial sustainability and service delivery
- 3. Implementing the recommendations of the Legislative Council Economy and Infrastructure Committee Inquiry into Local Government funding and services
- 4. Ensuring that additional duties and responsibilities placed on local government are accompanied by the resources needed to fulfil them
- 5. Increasing the quantum and reviewing the distribution of untied funding provided to local government to achieve the goal of horizontal fiscal equalisation
